## TERMS & CONDITIONS FOR WHY NOT WIN A MAZDA3 CONTEST (The "Contest")

# 4. Contest Specifics.

### 4.5. Contest Eligibility

4.5.1. To qualify for the Contest, you will need to purchase any of the Eligible Acer Product powered by Intel processor, and submit the form following the steps in 4.5.2.

- Step 1 Find and circle three (3) hidden words (Acer, Intel & Why Not) in the word puzzle in the Why Not Win A Mazda3 contest form.
- Step 2 Fill in your personal particulars in the requisite contest form.
- Step 3 Send the form via Facebook, fax or email with attachment, to the Program Centre.
- 4.6. The latest date and time of submission must be received by the Program Centre on the 11<sup>th</sup> October 2015, by 12:00PM.
- 4.7. You must provide the requested personal information. Incomplete submissions will be discarded without prior notice. An incomplete submission is a submission which does not have a complete filled contest form, without proof of purchase, and/or have incomplete details in the proof of purchase (without purchase item, quantity, serial number, invoice number, or invoice date).
- 4.8. You must retain your original paid invoice and/or receipt as proof of purchase. End-User/Purchaser may be required to present original proof of purchase when receiving their gift/prizes.

## 5. Prizes.

#### **Contest Prizes**

- 5.1. One (1) Grand Prize of a Mazda3 SKYACTIV CKD 2.0 Sedan (GL) (Metallic) worth RM109,341.

- 5.5. The retail price of the Mazda3 is:
  - 5.5.1. RM109,341.00 in the event the winner claims the price within Peninsular Malaysia.

### 6. How prize winners will be selected.

- 6.1. The prize winners will be shortlisted by Program Centre based upon total number of qualified contest entries received, divided by the number of contest prizes to be won. For example, if there are a total of 1,000 qualified contest entries, and there are 31 prizes to be given away, 1,000 divided by 31 is 32.26 which makes the 32<sup>nd</sup> entry for Grand Prize (taking the lower number), the 64<sup>th</sup> entry for first 2<sup>nd</sup> Prize (32x2), the 96<sup>th</sup> (32x3) entry for the second 2<sup>nd</sup> Prize, and so on. - 6.2. Once shortlisted, you will be contacted by the Program Centre to submit a copy of your purchase invoice/receipt for further verification. Upon successful verification, the Program Centre will notify you on being a prize winner.
- 6.3. If a winner is disqualified during the verification process, the qualified contest entry before the winning number shall be the next winner. For example, if the 32<sup>nd</sup> contest winner is disqualified, the 31<sup>st</sup> qualified contest entry will be the next winner.
