# \*TERMS & CONDITIONS FOR LENOVO BACK-TO-SCHOOL 4 PROMOTION (The "Promotion")

IMPORTANT: PLEASE READ THESE TERMS AND CONDITIONS (THESE "TERMS AND CONDITIONS") BEFORE ENTERING THIS PROMOTION. - 4.5. Promotion Eligibility
  - 4.5.1. To qualify for the rebate worth RM20, you will need to purchase the Eligible Lenovo Products worth RM1,000 and below, and submit the redemption form following the steps in 4.5.5.
  - 4.5.2. To qualify for the rebate worth RM50, you will need to purchase any of the Eligible Lenovo Products worth RM1,001 and above, and submit the redemption form following the steps in 4.5.5.
  - 4.5.3. To qualify for the one (1) free gift pack worth RM35, you will need to purchase the Eligible Lenovo Products worth RM1,000 and below, and submit the redemption form following the steps in 4.5.5.

#### 5.3. Rebates

- 5.3.1. The rebates shall be paid via online transfer to the claimant's bank as stated in the redemption form.
